

We the People Lawful Order and Judgment Summary



Wherefore:

I. WE THE PEOPLE WRIT SERVED ON SUPREME IMPOSTERS

Whereas, an Emergency Notice, Bill of Claims & Writ ("Writ") was directly served on John Glover Roberts, Jr., Elena Kagan, Sonia Sotomayor, Clarence Thomas, Samuel A. Alito, Jr., Neil M. Gorsuch, Brett M. Kavanaugh, Amy Coney Barrett & Ketanji Brown Jackson, nine men & women who are Private Corporate Shareholders masquerading as public servants as "Supreme Court Justices" & their clerk, Scott S. Harris ("Supreme Judicial Imposters") on March 1, 2024 by hand delivery, Certificate # MI-545 & by repeated electronic transmittals;

Whereas, the Writ sets for & commands remedy for Atrocity Crimes under international laws ⁱ & High Crimes perpetrated in the Child Sale & Genocide-by-Guardian Crime Syndicate by Supreme Judicial Imposters in conspiracy and cover up with their fellow Corporate Shareholders masquerading as public servants who falsely portray themselves as "legislative," "executive," "judicial" & other government employees ("Government Imposters");

Whereas, the Writ was served by Claimants, living men and women throughout the country some of whom are shown in the Claimant list who are subjected to Atrocity and High Crimes by Respondents, Supreme Judicial Imposters and their fellow Government Imposters;

Whereas, the Government Imposters running our country have secretively invented fraudulent codes they falsely portray as "laws" that steal our Unalienable Rights under color of law & fraudulent jurisdiction-less tribunals they falsely portray as "courts" to pretend they can mask & "legalize" their crimes & make them appear to be "civil matters" for them to run a criminal business of Child & Human Trafficking, Looting and Genocide, unquestionably, the biggest criminal enterprise in history (the "Child Sale & Genocide-by-Guardian Crime Syndicate");

Whereas, the Writ provides mandatory lawful remedy under Fundamental Sovereign, Substantive Law;

Whereas, recognizing & exposing that Government Imposters hide behind their secretively invented, self-serving, man-made procedural & corporate "Codes "& "Rules" that only bind them & not We the People, the Writ also holds them responsible to comply with their man-made codes by incorporating them into the Writ including those they call:

- 1. "Rule 65" that provides for automatic effective dates and time deadlines:
- 2. "Rule 55" that automatically effectuates "Default" against them;

Whereas Respondents, Supreme Judicial Imposters were instructed to affirm the Order by March 1, 2024 by signing & returning it to We the People at wethepeoplewrit@gmail.com & that failure to sign it self authenticates;

- 1. John Glover Roberts, Jr., Elena Kagan, Sonia Sotomayor, Clarence Thomas, Amy Coney Barrett, Samuel A. Alito, Jr., Neil M. Gorsuch, Brett M. Kavanaugh & Ketanji Brown Jackson & Scott Harris believes Child Sale, Human Traffic, Pillaging/Looting, Genocide-by-Guardianship, Murder for Hire (18 U.S.C. 1958) & other Crimes against Humanity are not Urgent and of Paramount Importance;
- 2. the foregoing named persons support and are complicit with these Crimes and the Perpetrators involved.

Whereas, any normal human being and legitimate public servant would report the Atrocity and High Crimes demand the immediate indictment & arrest of the Government Imposters;

Whereas, not so Respondents, Supreme Judicial Imposters;

Whereas, in response to the Emergency Writ served on them and in the face of Child Sell and Sex Trafficking, Human Trafficking, Loot and Genocide Crimes in process, these despicable Supreme Judicial Imposters circled the wagons around their crony fellow Government Imposters, Corporate Shareholders to protect, conceal, subvert & conspire with their Atrocity Crimes;

Whereas, the We the People Order thereby constitutes:

- 1. a Temporary Restraining Order/Injunction which took effect automatically on Friday, March 1, 2024 at 2:00 p.m. EST;
- 2. a Permanent Order that took effect on Friday, March 15, 2024 at 2:00 p.m. EST.

II. ALL PURPORTED "GOVERNMENT EMPLOYEES" ARE GOVERNMENT IMPOSTERS OPERATING UNDER COLOR AND COVER OF LAW

- 1. The United States of America Democratic Republic has been taken over, subverted & is run by a conglomerate of color of law fictitious jurisdiction-less private corporations ("U.S.A. INC.") registered with Dun & Bradstreet and other registration agencies including "SAM," an insider private corporation;
- 2. All branches and all agencies are jurisdiction-less Private Corporate Fictions operating under color and cover of law including those portrayed as the "United States of America," the "President," and "United States Supreme Court" as self-evident by their corporate registrations with Dun & Bradstreet as follows:
 - a. United States of America is "GOVERNMENT OF THE UNITED STATES" D-U-N-S # 161906193 and "THE UNITED STATES OF AMERICA" D-U-N-S #096226982;
 - b. U.S. President is "EXECUTIVE OFFICE OF THE UNITED STATES GOVERNMENT," D-U-N-S #161906078;
 - c. "United States Supreme Court" is "SUPREME COURT UNITED STATES" D-U-N-S #s 161906136 ("Subsidiary") & 111477469 ("Branch").
- 3. These Private Corporate Fictions masquerade as Public Servant Government Entities under color of law
- 4. All employees are Corporate Shareholders of Private Corporations falsely portrayed as "Public Servants."
- 5. Private Corporate Officers/Shareholders cannot be "Public Servant Government Employees."
- 6. Their loyalty is to each other, not to We the People.
- 7. Their interest is maximizing the profits of their Corporate business for their own benefit, NOT for We the People.

Now Therefore,

We the People Order hereby Secure, Defend, Protect & Enforce our Unalienable Rights; Hold Supreme Imposters Criminally and Civilly Liable; & hereby Order & Effectuate Urgent Mandatory Remedy as follows:

- 1. Cease and Desist;
- 2. All Federal & State "guardian laws," "conservator laws" & "family laws" in all Federal & State agencies are already void on their face & are hereby formally Abolished, Repealed & Nullified; all tribunals portrayed as "family" "guardian" and "probate" courts are disbanded & all decrees under the ruse of "orders" are vacated;
- 3. All people held under the control, custody of and/or designated as a "Ward" ("People") & all children held under the control, custody by anyone who is not their parent or the control or custody of a single parent where there are two parents by virtue of anyone purportedly acting under the "authority" of any government employee including judicial public servants are hereby released and their liberty, property, familial & all Unalienable Rights & the Unalienable Rights of their family are restored;
- 4. We the People hereby order the restitution of all property taken from all People and their family members by any Government Employee, including Judicial Imposters and/or anyone to whom any Judicial Imposter issued "decrees" allowing the taking and theft of the assets of the People and their family members;
- 5. Victim/Whistleblower/Witness Protection is provided to all People and their family members;
- 6. In the event of any threat or attempt to retaliate against any People or family member the police, National Guard and/or other law enforcement are directed to immediately issue an indictment against any party involved.
- 7. All property or that hereafter comes within the U.S. or control of any person involved in the theft of the People or their family members shall be blocked & frozen may not be transferred, paid, withdrawn, or otherwise removed.
- 8. A Sum in Excess of \$500,000,000,000,000 (Five Hundred Trillion Dollars) shall be funded, refunded in Massive Reparations to Claimants & Victims & our Pillaged Property Returned, just as was done by Germany.
- 9. This Order is effective immediately.
- 10. We the People call on Urgent Military Action & Maximum Sanctions against U.S.A. INC by all World Nations. All Government Imposters are hereby put on Notice.
